Furthermore, the sponsoring group agrees to indemnify and hold harmless the owner, his agents, affiliates, servants, and employees from and against any claim, suit or demand made or asserted by any individual member or participant of the sponsoring group for any personal injury, death or property damage incurred while using the facilities.

9. **Alcohol must be served, sold, or provided in accordance with Georgia law and the rules of this Agreement. Furthermore, the Land Owner, his agents, affiliates, servants and employees are not liable for personal injuries, death or property damage arising from intoxication. Under-age drinking at any event is strictly prohibited.**

10. A **Damage & Incidentals Fee** in the amount of **\$500.00** must accompany this application for use of the enclosed building or **\$350.00** for outdoors only, in addition to your fee. Damage & Incidentals Fee will be refunded in full within ten working days after function provided facilities are left in **clean** and orderly condition including removal of any game setups, mobile type vehicles and erected structures at conclusion of function on date used. You must supply table cloths for the inside tables. **THIS ALSO INCLUDES REMOVAL OF GARBAGE TO THE CONTAINER BEFORE LEAVING THE FACILITY AND REMOVING ANY SIGNAGE ON THE ROAD.**

- All reservations are on a first come, first served basis. No reservation is confirmed until full payment is received by check and a confirmation has been sent from our office. You may call and inquire about available dates but confirmation is based on receipt of payment. Any returned check will void your reservation. No overnight occupancy, with vacating no later than 12 midnight including clean-up.
- A container is located at the side of the building for trash disposal. Please make sure all bags are closed. Bags are provided by Taylor Farm Pavilion.
- The enclosed pavilion is now fully air-conditioned for summer use and fully heated for winter. Ceiling fans and windows are also available. Reservations are now taken on a year-round basis up to 18 months before your requested date.
